Minutes of Mersham Parish Council Meeting held on Monday, 15th September 2025 in the Church room at St John the Baptist Church

To receive and approve apologies for absence	
There were no apologies for absence.

Cllr Wells noted a personal interest in the Inland Border facility as a family member works on the site and a personal interest in the Village Hall.	
To approve the minutes of the meetings held on 21 st July 2025	
Minutes of the Meeting of Mersham Parish Council on 21st July 2025 were approved as a true record and were signed accordingly.

Cllr Murphy is still awaiting an update from Ben Oxney regarding the Cut and Cover.	
To receive report from County/Borough Councillor	
County Councillor	

Cllr Collins introduced himself as the newly elected Councillor for Ashford Rural East; he is also the Deputy leader of Kent County Council. He noted the installation of the 2 new pedestrian in road signs.

Cllr Collins noted that we may have noticed additional work on the roads, extra money has been invested but the roads will cost £billions to repair. Kent Highways are negotiating with a new contractor; they hope that a warranty could be provided. Cllr Osborne is the portfolio holder for Highways, he is aware that processes need to change and all are encouraged to report pot holes. KCC are working on plans for a pothole reporting app and hope that something will be available early next year.

Please report pot holes, if they are marked but not fixed within 4weeks, please contact Cllr Collins.

Cllr Collins was asked about fly tipping, he said this needs looking at because use of the tip is not easy.

Speeding in the village was discussed; no traffic calming measures would work because the roads are too narrow. Cllr Collins suggested that signalling could be looked into and asked for copies of the HIP.

The light having been removed from the junction on the A20 was discussed. Cllr Collins is to look into this. Cllr Collins also explained that he is waiting for an update on the bridge at lower Mersham. Cllr Collins was asked to provide an update, this is scheduled for 2026.

The tractors damaging the bollards by the bridge in lower Mersham, this is thought to have been the Sims Agri driver, and Cllr Murphy said he would write to them to raise the issue.

Cllr Collins explained that the 14 Councils have been asked to submit plans, 12 of the Councils are suggesting either a 3 or 4 split Unitary Authority but KCC are submitting plans for a single Unitary Authority. A response has to be submitted to the Government by November 28th and a response is expected in Spring/Summer 2026. Now that Angela Rayner and Jim McMahon are no longer part of the cabinet, it may be that Unitary Authority division is not on track.

Borough Councillor

Cllr Bartlett reported:

There is a consultation on the Local Plan on 25/9 at the Village Hall. This is an "Areas of search" consultation and it was suggested that the PC could concentrate on Highways access to the Church Commissioners land. Currently access is difficult over the narrow bridge on Cheesemans Green Lane, on the bend on Station Road and the bend at the shop in Mersham. The original plans showed a road from J10a to Finberry but this was not built.

The Borough Council Planning Committee meeting on 24th September will include the Borough Council response to the PINS application for the IBF. Cllr Murphy will attend to speak on behalf of Mersham. The main points that Cllr Bartlett noted were:

Lost lorry issues must be fixed, the protection of High Field needs to not be ambiguous and needs a management plan in place. The lorry "hum" needs to be dealt with, lighting, litter and the weak acoustic barriers are all issues. The temporary solutions need to be fixed now that this is a permanent feature. The lighting could be reduced dramatically if only the used lanes were lit. A transport plan is required to ease the traffic on the A20 and to stop lorries from parking on J10a.

Noise from the motorway is causing some issues for residents in Mersham. This is due to the break down of the sound barrier surfacing. PC to contact National Highways.
